

- 3. Tenders will be considered firm for acceptance for a period of six months from the last date fixed for receipt of filled and duly signed Tenders. Tenderers are not free to withdraw or modify the tenders during this firm period.
- 4. In case of any matter which is not covered by this Tender Notification, or the general terms and conditions of the contract or the specifications etc. as given herewith, the decision of the Executive Director, CWRDM shall be binding on the Tenderer.
- 5. The acceptance of this Tender rests with the competent authorities as per the rules of the CWRDM who do not undertake to accept the lowest or any particular Tender or assign any reason for the rejection of any Tender.
- 6. Any further information regarding this Tender which the CWRDM do not consider to be kept confidential, can be obtained from Office of the CWRDM during working hours on any day prior to the last date fixed for the receipt of Tenders.
- 7. Tenders will be opened on the next working day after the due date at **3 PM**. However, placing of final orders will depend upon the close scrutiny of Tenders by a duly constituted Purchase Committee in due course.
- 8. Successfull tenderesr should remit the Performance Security 5% of executed amount (by means of DD) from any nationalized bank drawn infavour of Executive Director, CWRDM payable at Calicut or as Bank Guarantee valid for one year.
- 9. The Tenderer should execute an agreement in stamp paper of value Rs.200/- as per the enclosed format.
- 10. The rate quoted in the Tender should be valid for 180 days or more and inclusive of GST.
- 11. The maximum period required for delivery should be mentioned in the Tender.
- 12. No representation for enhancement of price once accepted will be considered during the currency of the contract.
