1. Quotation should be in sealed envelopes super scribed as 'Quotation for Refrigerator' and submitted in the prescribed form with all required details, to the Registrar, CWRDM, Kunnamangalam P.O, Kozhikode- 673 571, Kerala, on or before **13-01-2026, 5PM.**
2. Quotation which do not conform to the terms and conditions (clauses) of this Notification will be rejected.
3. Quotation will be considered firm for acceptance for a period of six months from the last date fixed for receipt of quotations. The rate and amount of GST, Insurance, Freight, Packing, forwarding, etc. should be shown separately. Installation, demonstration and training should be given free of cost. Quotation not stipulating period of firmness and with price variation clause and/or subject to the prior sales conditions, are liable to be rejected
4. In case of any matter which is not covered by this notification, or the general terms and conditions of the contract or the specifications etc. as given herewith, the decision of the Executive Director, CWRDM shall be binding on the Tenderer.
5. The acceptance of this Quotation rests with the competent authorities as per the rules of the CWRDM who do not undertake to accept the lowest or any particular Quotation or assign any reason for the rejection of any quotation.
6. Any further information regarding this Quotation which the CWRDM do not consider to be kept confidential, can be obtained from Office of the CWRDM during working hours on any day prior to the last date fixed for the receipt of Quotation.
7. Quotation should be submitted with complete technical literature/manual and required details for the supply.
8. Quotation will be opened on next working day after the due date at 11 AM.
9. The maximum period required for Delivery, Installation, etc. should be mentioned in the quotation and the item should be delivered to **CWRDM Sub Centre, Manimalakunnu, Oliyappuram P O, Koothattukulam, Ernakulam – 686 679, Ph.0485 2963517**
10. If the tenderer has ISI/ISO/BIS for products and factory, the same may also be mentioned separately in the quotation with the supporting Certificates and Orders.
11. In case of non-imported items, payment will be made only after the supply is received in good condition, Installation, carried out satisfactorily.
12. The manufacturer should be of International standards and all the specifications should also correlate with the original literature. If the tenderer is the distributor for

these items relevant Certificates of the manufacturers /authorized distributorship Certificate, manufacturers certificate for spare parts availability for a minimum period of 5 years and service facility for the quoted model/instrument etc. should be forwarded along with the quotation.

13. The Tenderer should have service facility in Kerala/ South India and should specify the service back up facility.
