2. Quotation which does not conform to the terms and conditions (clauses) of this Notification will be rejected.
3. Quotation will be considered firm for acceptance for a period of six months from the last date fixed for receipt of quotations. The rate and amount of GST, Freight, Packing, forwarding, etc should be shown separately. Quotation not stipulating period of firmness and with price variation clause and/or subject to the prior sales conditions, are liable to be rejected
4. In case of any matter which is not covered by this notification, or the general terms and conditions of the contract or the specifications etc. as given herewith, the decision of the Executive Director, CWRDM shall be binding on the Tenderer.
5. The acceptance of this Quotation rests with the competent authorities as per the rules of the CWRDM who do not undertake to accept the lowest or any particular Quotation or assign any reason for the rejection of any Quotation.

7. Quotation should be submitted with complete technical literature/manual and required details for the supply.
8. Quotation will be opened on the same day at 4 PM. The maximum period required for Delivery/Construction, should be mentioned in the quotation and the item should be delivered/constructed in CWRDM Campus at Kottamparamba, Kunnamangalam, Kozhikode- 673 571.
9. If the tenderer has ISI/ISO/BIS for products and factory, the same may also be mentioned separately in the quotation with the supporting Certificates and Orders.
10. In case of non-imported items, payment will be made only after the supply/work is done satisfactorily.
11. The Bidder should have service facility in Kerala/ South India and should specify the service back up facility.
