Centre for Water Resources Development and Management invites sealed tenders from reputed firms for supplying Electrical items for a period of one year under Running contract system

Terms and Conditions:-

1. Tender should be submitted in closed cover superscribed as **“Running Contract for Supply of Electrical Items”** with due date and submitted to the Registrar, CWRDM, Kunnamagalam, Kozhikode 673571 on or before **22-06-2024, 5PM**.
2. The firms should be registered with GST authorities. The contract will be generally valid for **'a minimum period of one year'**, however rates for more than one year will also be considered. The tenderer who cannot provide validity of rates for one year need not apply.
3. The Tenderer should submit an agreement (preliminary) along with the tender executed and signed in the prescribed format, in Kerala stamp paper of value Rs.200/-, purchased in Kerala state
4. There will be no change in price structure during the currency of the contract except for the statutory levies which are made applicable by the Govt. through notifications/ regulations change
5. The Tenderers should have 2 or more Contracts in the past three years and should enclose the proof of supporting documents along with the quotations.
6. The stores should be supplied within 7 (Seven) days from the date of receipt of supply order either directly or through dealer. Earlier delivery by the supplier is preferred. If the supplier fails to deliver the material within the delivery period as specified, purchaser may procure such items as it deems appropriate considering the

urgency and in that event, the supplier will be liable to make good the loss occurred if any, for the excess rate paid by the Centre.

7. The items should be delivered at CWRDM Campus at Kottamparamba, Kunnamangalam, Kozhikode- 673 571.
8. Termination of Contract:- The contract can be terminated at any time without assigning any reasons by giving one month notice by either party.
9. Conditional, Unsigned, Late & Delayed tenders will not be considered.
10. The items supplied shall be of good quality and grade and on inspection/test if these are found to be of inferior quality, the same has to be replaced by the supplier at their cost within the stipulated period, failing which, the contract of the firm may be cancelled. Delayed supply/non-compliance of order may also lead to cancellation of Contract.
11. The payment for the supply of items will be given to the firm within one month of the delivery of materials subject to the inspection of materials by Indenter. **No Bill for part Payment will normally be entertained.**
12. Discount, taxes and other levies, if any, are to be specified clearly in the bid.
13. Warranty - The tenderer shall be fully responsible for the manufacturer warranty in respect of quality and workmanship of the materials covered in the Contract. In case of any defects found at the time of use, the supplier will provide free replacement or refund the amount charged for that item.
14. Tenders which do not conform to the terms and conditions (clauses) of this Notification will be summarily rejected.
15. The tenders will be opened on **24-06-2024 at 3.00 P.M.** in the presence of the tenderer (who are at present). However, placing of final orders will depend upon the close scrutiny of Tenders by a duly constituted Purchase Committee in due course.
16. Successful Tenderer shall submit an agreement executed and signed in the prescribed format, in Kerala stamp paper of value Rs.200/-, and Performance security equal to 5% of total estimated cost by means of Bank Guarantee.
17. If the tender have ISI/ISO/BIS for products and factory, the same may also be mentioned separately in the Tender with the supporting Certificates and Orders.
18. CWRDM reserves the right to reject any or all of the Tenders without assigning any reasons thereof. In case of any dispute the jurisdiction shall be Kozhikode District.
